1804. 6 July. Ordinance concerning foreign Slaves living in the Colony.

We His Majesty's Governor & Council on the Island of St. Bartholomew.

Make known; that having found ineffectual the Ordinance of the Council of the 22 December 1797, by which all persons dwelling in foreign countries, and who have slaves in this Colony, are bound to place their said slaves under the Guard of some of the Inhabitants of this Colony, and at same time, to give or cause to be given notice thereof to the Government, under penalty of confiscation of the slaves; as also, that all coloured people, calling themselves free, should present themselves at the Government in order to prove their freedom, under penalty of being banished or sold as slaves without Masters, Considering, that in want of regular execution of such ordinance the Country might by length of time be filled up by run away slaves out of the Controul of the Police, & wishing to prevent the evil, that might result therefrom; We have under the approbation of His Majesty, Our most Gracious Sovereign, decreed and Ordained as follows.

1°. All Slaves living or working in this Colony with the good will & consent of their Masters, but whose Masters are or may be living in foreign Countries, shall by the Masters be placed under the Guard of persons well known and living in this Colony, either by an act, or a Letter at least, specifying the name & age of the Slave with his Trade as well as the person, to whom he is trusted.

2°. All persons, who shall have accepted of such confidence, shall give notice thereof in the Court Office, where the act or Letter of the Proprietor shall be vifed, and they shall be bound to the same responsibility for the slaves to them entrusted, as if real owners.

3°. All foreign Slaves, whose Masters shall not have complied or cause to be complied with the formality now hereabove prescribed, in three months from the proclamation hereof, shall on prosecution be confiscated One half to the benefit of the King, & the remnant half to him or them, who shall have prosecuted & for other expences.

4°. **All coloured people calling themselves free, without being manumitted by an Act of the Council of this Island, shall without delay prove their freedom before the justitarius of the Island & the proofs, if acknowledged, shall be registered on the Book kept for that purpose at the Court office**; but if there shall be found persons calling themselves free, without being provided with Titles of their freedom, they shall be obliged to leave the Country within the delay of Fifteen days, under penalty of imprisonment & being published for claims by the Owners, & finally and in want of claimants, of being sold as slaves without Masters, to the benefit of the King and the prosecutor, in the way hereafore prescribed; Unless they can procure the security of Two such Inhabitants of the Country as in Justice may be accepted for such a delay, as may be granted them, for the purpose of qualifying themselves, in respect to the Vouchers of their freedom; but after such delay, if still failing in Titles, they shall be bound to leave the Country, without any further delay, under the above prescribed penalty.

5°. All persons are forbid to give lodging to any persons calling themselves free, who shall not be qualified in the manner hereafore prescribed, under penalty of Twenty Dollars, in fine & all Damages besides.

6°. No coloured Stranger passing for free shall be allowed to land in this Island, without his freedom being previously acknowledged, or security therefore given as aforefaid; Nor shall any slave belonging to strangers living in foreign Countries be landed, without being bound to the care of some person living in this Island as above stipulated, to whom he may be delivered, all under penalty of Twenty Dollars payable by the Captain of the Vessel, in which they arrive & at whose expence they shall be brought away from the Country, and under Penalty of imprisonment to the pretended free or the slave, untill an opportunity of Sending them off shall be found.

Finally We do invite all and every one of the Inhabitants of this Island and especially the Representatives of the Town of Gustavia, and We do order the vice Fiscal, Harbour Master, and all others entrusted with some care of the Police to enforce the present Ordinance, to report and prosecute, whenever the same shall have been transgressed.

Given under Our hands & the Seal of the Royal Council in Gustavia on the Island of St. Bartholomew the 6th. of July 1804.
